I warrant and acknowledge that I am the parent or legal guardian of the minor child named above (“Participant”), that the Participant is a minor under the age of 18 and that I am authorized to, and do, on behalf of myself, Participant and our heirs, assigns and next of kin, hereby enter into the following agreements IN CONSIDERATION OF Participant and/or me being able to be near, enter, or participate in activities in any manner sanctioned, operated or sponsored by any of Hawaii State Referee Committee, an unincorporated nonprofit association, Hawaii Soccer Association, a Hawaii nonprofit corporation, Hawaii Youth Soccer Association, a Hawaii nonprofit corporation also known as HYSA, or any entity or organization that is part of or affiliated with any of the foregoing including without limitation the organizations described in Exhibit A which is attached hereto and incorporated herein (all of these are called the “SOCCER ORGANIZATIONS”). All of the occurrences or activities described in this paragraph are called “ACTIVITIES”..

I acknowledge that participation in ACTIVITIES necessarily involves activity or circumstances that may result in illness, disease and other consequences up to and including death including without limitation contagious or communicable illness or disease, including but not limited to, “severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)”, the virus which is responsible for Novel Coronavirus Disease (COVID-19) and/or any mutation or variation of either.

I WILLINGLY AND VOLUNTARILY ASSUME ALL RISKS REGARDING THE FOREGOING ON BEHALF OF PARTICIPANT, MYSELF AND OUR RESPECTIVE HEIRS, ASSIGNS AND NEXT OF KIN. If I or Participant have or observe any concern about Participant’s or my readiness for participation in, or about any unacceptable risk related to, the ACTIVITIES, I will remove him/her and myself from participation.

I HEREBY RELEASE AND DISCHARGE ON BEHALF OF PARTICIPANT, MYSELF AND OUR RESPECTIVE HEIRS, ASSIGNS AND NEXT OF KIN, AND I AGREE TO INDEMNIFY, HOLD HARMLESS AND DEFEND, to the fullest extent permitted by law, any and all of the SOCCER ORGANIZATIONS and their respective volunteers, coaches, assignors, assessors, employees, agents, officers, directors, owners and other representatives and any and all owners, lessors, lessees or other persons or entities allowing, permitting or authorizing the use of facilities or premises by any of the SOCCER ORGANIZATIONS and the agents, employees, officers, directors owners of any of said persons or entities (“RELEASEES”) from any and all liability, claims, demands, costs, expenses and compensation arising out of or in any way related to any contagious or communicable illness or disease that may result to Participant, me or to

members of Participant's or my family or my household or individuals I invite or for whom I am otherwise responsible while participating in or present at any of the ACTIVITIES, WHETHER ARISING FROM THE NEGLIGENCE OF ANY OF THE RELEASEES OR OTHERWISE.

I further acknowledge and accept that this document is intended to be as broad and inclusive as permitted by the laws of the State of Hawaii and agree that if any portion of this document is deemed to be invalid, the remainder will continue in full legal force and effect.

I warrant and promise that I understand and have explained or will promptly explain the provisions of this document to Participant to the best of his or her ability to understand it and the importance of following the rules and guidance of any of the SOCCER ORGANIZATIONS in whose activities I am participating and following the the directions or instructions of duly authorized personnel.
